## NEXIUM \$15 SAVINGS OFFER

If you already have a prescription for NEXIUM, simply take this printout to your pharmacy to begin receiving savings on out-of-pocket costs that exceed \$15 (up to a \$125 savings limit) on each 30-day supply of NEXIUM.

**ELIGIBILITY:** You may be eligible for this offer if you are insured by commercial insurance and your insurance does not cover the full cost of your prescription, or you are not insured and are responsible for the cost of your prescriptions. Patients who are enrolled in a state or federally funded prescription insurance program are not eligible for this offer. The patient is responsible for the first \$15 on 30-day supply, \$30 on 60-day supply, or \$30 on 90-day supply and the card will cover up to \$125 per 30-day supply. Reimbursement will be received from **Therapy First Plus**.

**PHARMACIST INSTRUCTIONS FOR A CASH-PAYING PATIENT:** Submit the claim to **Therapy First Plus**. A valid **Other Coverage Code (eg, 1)** is required. The patient is responsible for the first \$15 on 30-day supply, \$30 on 60-day supply, or \$30 on 90-day supply and the card will cover up to \$125 per 30-day supply. Reimbursement will be received from **Therapy First Plus**.
